We need more information before we can complete our consideration of your application for exemption. Please provide the information requested on the enclosure by the response due date shown above. Your response must be signed by an authorized person or an officer whose name is listed on your application. Also, the information you submit should be accompanied by the following declaration:

Please attach a copy of this letter and the enclosed Application Identification Sheet to all correspondence related to your application. This will enable us to associate the additional correspondence or documents with your application case file quickly and accurately, to facilitate processing of your application.

If we do not hear from you within that time, we will assume you no longer want us to consider your application for exemption and will close your case. As a result, the Internal Revenue Service will treat you as a taxable entity. If we receive the information after the response due date, we may ask you to send us a new application.

In addition, if you do not respond to the information request by the due date, we will conclude that you have not taken all reasonable steps to complete your application for exemption. Under Code section 7428(b)(2), you must show that you have taken all the reasonable steps to obtain your exemption letter under IRS procedures in a timely manner and exhausted your administrative remedies before you can pursue a declaratory judgment. Accordingly, if you fail to timely provide the information we need to enable us to act on your application, you may lose your rights to a declaratory judgment under Code section 7428.

To be tax exempt under the code, an organization must be organized and operated exclusively for charitable, educational purpose defined under the Code.

In general, prolife or abortion is a matter of public concern and there are different opinions on this issue.

An organization may advocate the adoption of objective that are controversial. However, it's activities may serve educational purpose if the activities are nevertheless designed to increase the knowledge and understanding of the public on its viewpoint. (See Revenue Ruling 68-656, 1968-2 CB 216, and Revenue Ruling 76-81, 1976-1 CB 156)

In section 3.02 of Rev. Proc. 86-43, *supra*, it states:

"Although the Service renders no judgment as to the viewpoint or position of the organization, the Service will look to the method used by the organization to develop and present its views. The method used by the organization will not be considered educational if it fails to provide a factual foundation for the viewpoint or position being advocated, or if it fails to provide a development from the relevant facts that would materially aid a listener or reader in a learning process."

From the provisions in Article II, item 2.3 of your Bylaws, and from the information presented in your website, it appears that some of your activities, conducted or plan to conduct, may be neither educational nor charitable in nature no matter how sincere of your religious belief or how important of your viewpoint.

- Carrying out prayer and evangelization at abortion clinic sites;
- Activities that are conducted to expose the racist agenda (as you claimed) of the abortion industry;
- Activities calling for group actions against another group holding different viewpoints. (See attached information downloaded or cited from your website.)

If more than insubstantially of your organization's activities are beyond the scope of section 501(c)(3) of the Code, and are intend to achieve any specific purposes other than the purposes defined under the code, you may wish to withdraw your application.

Otherwise, please explain how the activities, listed as underlined above are serving educational or charitable purposes within the scope of section 501(c)(3) of the Code.

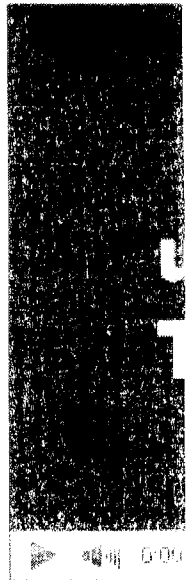
Nurse: "You are harassing and accosting my patients!"

Us: "Ma'am, all I am doing is handing out information. People need to know that you provide abortion referrals here."

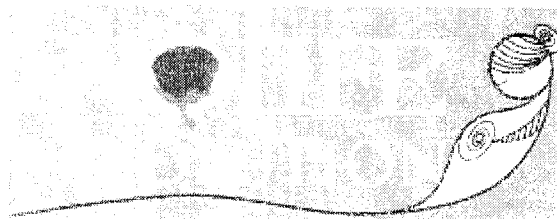
Nurse: "We do not do such thing! And besides, women have a choice! I am calling the police!"
